 - i. Student Enrollment for Next Year Information sessions during open enrollment were very well attended. We accepted all kindergarten applicants and will be almost at capacity with parents accepting seats and sending in paperwork; 1st grade 16 applied; second grade 11 applied; third grade 6 applied; fourth grade 21 applications. Our current enrollment for 2022-23 is 305.
 - ii. Teacher & Staff Recruitment Still conducting interviews and have offered employment to 5 more teachers who accepted and will join the team next school year. Ongoing search for a certified nurse assistant and facilities personnel.



- iii. School-wide Events & Celebrations We celebrated Holidays Around the World before Winter Break. In January, we celebrated Literacy week and Mote Aquarium animal adoptions, Field Trips to Jungle Gardens and Mote Aquarium. In February, PTC Fun Run fundraiser was a success and funds raised will be used for the outdoor learning space. We also celebrate our Reading buddies & in school field trips for literacy and math activities.
- iv. Progress Monitoring 2 complete Our students are showing academic growth.
- v. Based on data and demand, we will start a cohort for an Advanced Work Class (AWC) 1st and 2nd grades to provide more enrichment, depth of knowledge, and project-based learning next school year.

- vii. Night of Dreams Gala preparation to fundraise for our outside learning space is going well and expect a good turnout.
